Subject: Reg.-Exemption to the Persons with Disabilities and Pregnant women employees from attending the office during curfew period.

Madam/Sir,

This is with reference to DDMA Order No. 381 dated 19.04.2021 regarding imposition of curfew which has further been extended vide Order No. 397 dated 25.04.2021 and Order No. 407 dated 01.05.2021, till 05.00AM on 10.05.2021.

In this regard, it is to clarify that, considering the health and safety, Persons with Disabilities and Pregnant women employees shall be exempted from attending the duties (related to essential as well as non essential services) in the offices of Departments/PSUs/Corporations/ Autonomous Bodies/ Local Bodies of Govt. of NCT of Delhi during curfew period, but they shall have regular communication with their office through available mode of communication i.e. mobile phone, email etc. and they shall continue to work from home.
