In order to implement Govt. Guidelines so as to ensure rational & judicial use of oxygen in the management of Covid-19 patients an Oxygen Audit Committee is constituted comprising of following officials:

The Committee will supervise inventory planning, Oxygen Consumption pattern, regularize repair & maintenance of gas pipeline, gas plant and wall mounted gas outlets etc through concerned Nodal Officers/Medical Officer in-charges. It will review the consumption pattern of oxygen twice a week and conduct Audit and reduce oxygen consumption if found to be in excess.

Further an **Oxygen Monitoring Team** comprising of one Nurse & one OT technician shall be constituted by concerned ward in-charge in coordination with HOD Anesthesia (for OT technician) for each shift, will visit all areas where Oxygen supply/therapy is instituted to

- Inspect the gas pipeline, wall mounted gas outlets, as well as gas cylinders to detect and promptly address leakages, if any. Nurse in the team will check the oxygen mask on a regular basis.
- Ensure closure of valves during "no-use" at all times.
- Sensitize nurses and technicians for conservation of oxygen.
