Brief of the judgment is as follows:

As per the judgment passed by National Consumer Disputes Redressal Commission (NCDRC) on the case pertaining to the death of a three year old child suffering from cancer, the doctor rendering treatment to the patient and hospital (vicariously) committed gross negligence. The patient died after the injection was wrongly administered by one of the Assisting Doctors in the team led by Primary Doctor. The Commission held the hospital and the primary doctor responsible for the entire treatment rendered under his care including by the team who assists him in rendering treatment. The incident quoted as pertains to Mohan Dai Oswal Cancer Treatment and Research Foundation Hospital, Ludhiana.

All are requested to ensure strict compliance to standard clinical protocols and regular training of their team on the same.
