In reference to subject cited above it is to bring to your kind notice that the Transgender Person (Protection of Rights) Act 2019, has been en icled in December 2019. In compliance to

I. Section 15 (f), Chapter VI of the Transgender Person (Protection of Rights) Act, 2019 it is mandated that:

"to facilitate access to transgender person in his, ital, and contain in althour institutions and centers"

Section 10 (5) and 10 (9) of Transgender Person (Protection of Rights) Rules, 2020 it is mandated that;

 Section 10 (5) "The appropriate Government shall create institutional and infrastructure facilities, including but not limited to rehabilitation centre referred to In sub-section (3) of section 12 of the Act, separate human immunodeficiency

virus sero-surveillance centres, separate wards in hospitals and washrooms in the establishment, within two years from the date of coming into force of these rules to protect the rights of transgender persons."

2 Section 10 (9) The appropriate Government shall create institutional and infrastructure facilities, including but not limited to, temporary shelters, short-stay homes and accommodation, choice of male, female or separate wards in hospitals and washrooms in the establishment within two years from the date of coming into force of these rules to protect the rights of transgender persons."

In order to facilitate access to transgender persons in hospitals and other healthcare institutions and centers, you are requested to designate dedicated transgender wards in every government hospital in Dolhi, even if it is a small ward (2-3 beds), as transgender persons suffer high rate of infections of diseases viz. HIV and TB. This would go a long way in mitigating the problems faced by this marginalized community and be a positive step by Delhi government in implementing the provisions of Transgender Person (Protection of Rights) Act, 2019
